PUBLIC COMMENT

BOB LONGLEY-LONGLEY INSURANCE

Bob Longley explained the Pennsylvania Firefighters Cancer Presumption Law.

This has impact on the Borough's Worker's Compensation Insurance. The Worker's Compensation market is rapidly drying up and changing for municipalities because of the law. The Law is rebuttable and if the firefighters meet certain criteria which are relatively easy to meet it is presumed that they got their cancer from fighting fires. Following is the criteria: The firefighter must be actively involved with the fire company for four years continually; the last medical checkup they showed no condition of cancer and; they have to be exposed to a type one carcinogen which has to be within 300 weeks of the last exposure. Municipalities can rebut it with substantial competent evidence. All the claims so far have been challenged and only time will tell where this will all go. Because of the Law, the workmen's compensation premium will drastically increase.
