AVONDALE BOROUGH COUNCIL MEETING May 28, 2019 6:00 P.M.

STATE REPRESENTATIVE CHRISTINA SAPPEY

Representative Sappey said she has been making her rounds to local governments introducing herself and letting everyone know were her office is located and her contact information. Her office can help with State issues so if the Borough residents need help in this area please send them her way. Also, if she can help with support letters for grants or anything else please let her know. Representative Sappey discussed some of the issues she is addressing at the State level. Council thanked Representative Sappey for coming to the meeting.

APPROVAL OF MINUTES

WWTP OPERATIONS REPORT

Fred Walton gave the following report:

DRINKING WATER SYSTEM

All systems online and ok. Well #2 flow meter is not working. The 2 portable chlorine meters were certified for compliance with the DRR method 334. The wells run about 8 hours a day with a monthly total of 2,683,220 pumped.

WASTEWATER TREATMENT PLANT

All systems are online, except the influent screener and effluent chlorine analyzer. The Month of April we had a total of 12,614,100 gallons of influent and 13,488,800 were treated. The effluent chlorine analyzer is scheduled to be replaced by M & S with a Hach CL17 analyzer the same as the drinking water analyzer. The screener is scheduled to be serviced by MGK (they are waiting on the parts). We had to remove RAS Pump #2 due to vibration.

BOROUGH ENGINEER'S REPORT

Jamie MacCombie gave the following report:

NEW WATER SUPPLY & CONSTRUCTION RELEASE

The contractor completed the directional drilling under Pennsylvania Avenue. There is a construction release that needs to be approved by Council. Steve Cummings made a motion to approve the Construction Release subject the County's approval, 2nd by Dave Besselman, motion carried. Three bids

were received for the Electrical with Mike LaFrance being the lowest at \$18,100. The Borough will have to pay for the electrical. Wilson Lysle made a motion to approve Mike LaFrance to do the electrical, 2nd by Dave Besselman, motion carried.

RESOLUTION 2109-01 - GRANT APPPLICATION FOR STREAMBANK STABILIZATION ON INDIAN RUN ROAD Dave Besselman made motion to adopt Resolution 2019-01, 2nd by Steve Cummings, motion carried.

Pipe Data was on site today to do the televising. Quotations were received but Council needs clarification.

BOROUGH SOLICITOR'S REPORT

WILKINSON PROJECT

As of July 2019, the permanent extension act ends which gave certain development rights. Kim said she would like to send Wilkinson a letter stating no more extensions will be given and advising them that the extension ends. Jamie will work with Kim on the letter.

CUTONE MUSHROOM UPDATE

The work has been completed. President Shore said there is a tree down in the creek from the Cutone property. Mike Cutone has not removed the tree. Kim said she would contact Mr. Cutone.

NEW WATER MAIN-LONDON GROVE TOWNSHIP

A letter will be sent to the London Grove Township water customers on Pennsylvania Avenue making them aware of the water main project and the impact it may have on their service lines.
