# AVONDALE BOROUGH COUNCIL MEETING MAY 17, 2016 6:00 P.M.

After an opening prayer and the Pledge of Allegiance the meeting was called to order by President Shore at 6:00 p.m.

#### **ANNOUNCEMENT**

There was an Executive Session held after the April 19, 2016 Borough Council meeting to discuss possible litigation on the Wilkinson Project

#### **PUBLIC COMMENTS**

#### MICHAEL TANTAROS – 420 CHATHAM STREET

Mr. Tantaros said he has lived in the Borough for the past 20 years and he lives at 420 Chatham Street that has an unoccupied building in the back of his property that was used as a radiator repair shop before he purchased the property. Back in February he realized he could not keep this property unless there was additional income. Upon submitting a recent permit application to the Borough to renovate the building into a rental unit; he learned that he would owe tapping fees for water and sewer. Mr. Tantaros said he is here to appeal this decision to charge the fees and asked Council to reconsider because he can't afford the fees.

President Shore said the Borough's Solicitor and Engineer researched the ordinance and both have come to the conclusion that it is clear in the ordinance that you would be required to pay the fees since the use of the building would be changing to a rental unit.

#### **PUBLIC WORK'S DEPARMENT REPORT**

Rick Davis gave the following report:

#### PAVING ESTIMATES - VERIZON JOB

Received four estimates for paving the Verizon inlet job. The lowest estimate came from Keystone Paving for \$2,250.00. Dave Besselman made a motion to approve the estimate from Keystone Paving for \$2,250.00, 2<sup>nd</sup> by Steve Cummings, motion carried. This expense will be billed to Verizon.

#### GREASE SEWER BLOCKAGE - 91 PENNSYLVANIA AVENUE

Discovered a sewer blockage at 91 Pennsylvania Avenue; the lateral was completely blocked and the manhole extremely dirty due to grease build up. The homeowner Rich Wannemacher was notified and McGovern's pumped and jet cleaned the line. The homeowner should be billed for this cleaning due to grease generated by this property. Jamie MacCombie said a normal house will not generate enough grease to create a blockage. Requiring grease traps for out of the ordinary homes was discussed. Mr. MacCombie will send a draft ordinance to Kim Venzie for her review for the property's that generates excessive grease.

Jennifer Fields from DEP approved the sewer connection from Anholt to Avondale Borough. We are waiting on Anholt decision on how they want to move forward.

#### NEW WATER SUPPLY UPDATE

We need 24 hour pumping and additional testing to be done. Eichelberger Well Drillers wants \$9,929.70 for the pumping services and Brickhouse wants \$8,810.00 for testing and reports. Mr. MacCombie said he needs the reports to get the well permit. Kim Venzie will call Brickhouse regarding their open ended proposal.

#### WATER AND SEWER CONNECTION APPROVAL - 325 CHURCH STREET

Abby Pyle made a motion to approve water and sewer connection for a new single family dwelling at 325 Church Street,  $2^{nd}$  by Steve Cummings.
