ROUTE 1 ECONONOMIC DEVELOPMENT

The Chester County Economic Council wants to find out what the municipalities want along the Route 1 Corridor and how we can help. The Route 1 Corridor goes from Pennsbury Township to West Nottingham Township. Bill Shore said any new development will end up on Route 41 and that is a big problem. The Borough has a couple parcels and one developer who hasn't finished his housing development of 200+ townhomes located by the quarry but other than that we are built out.

Bob Grabus said Route 41 just has to be worked on and he has made it a mission of his to make sure he raises the issues to the highest level. Until we solve the issues with Route 41 this whole area is impeded. Mr. Grabus said he has been talking to the Commissioners, the County Transportation planner, Senators, and Congressman. Bill Shore asked if there is anything the Borough can do to give him support. Mr. Grabus said he would love to sit down with a few people from the Borough and find out the needs and issues are of the Borough. Mr. Grabus will set up a meeting with the Secretary.
